Your proxy will also be entitled to vote at his or her discretion or to abstain from voting on any resolution properly put to the said Meeting other than those referred to in the notice convening the Meeting.

- This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must either be executed under the common seal or be signed by an officer or attorney so authorised.
- Where there are joint registered holders of any share(s), if more than one of such joint holders be present at the Meeting or any adjournment thereof, whether in person or by proxy, that one of the said persons so present whose name stands first in the Company's register of members in respect of such share(s) shall alone be entitled to vote in respect thereof.
- In order to be valid, this completed form of proxy, together with the power of attorney, if any, under which it is signed, must be delivered to the Company's share registrar and transfer office, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than forty-eight (48) hours before the time appointed for holding the Meeting or any adjournment thereof, as the case may be. 8.
